- ❖ Effectively train all our personnel in the Company's requirements to adopt Food Safety practices and pay due regard to Personnel Hygiene.
- ❖ Using **Corrective and Preventive Actions** and reviewing their effectiveness to **Continuously Improve the Site's Product Safety, Quality standards & Quality Culture** and thereby increase profitability.

Plastic is regarded as inert, **no nut oil, shellfish or their derivatives** is used on this premises. We therefore pledge to supply Safe and Legal Products (when used solely for their intended purpose) to our customers.

To ensure that we meet our Product Safety related duties and responsibilities, we are **currently certificated** to the **BRCGS Packaging Materials**. This **Product Safety & Quality Policy** is complementary to any other Systems in operation across the business.
